CONSENT

to processing of personal data

1.  - 9. I hereby confirm that I am the subject of provided personal data, the personal data are provided by myself, and I confirm the validity, completeness, accuracy of the provided data, the personal data provided do not violate the current legislation of the Russian Federation, the legal rights and interests of third parties.

In the event that substantial changes are made hereto, such Consent will be subject to publication on the Website, and the relevant changes become effective within 20 (twenty) business days from the date of the official publication of the new version of the Consent on the Website.

If I do not declare in writing a refusal to accept the changes within the specified period, this will express my consent to the processing of personal data in the manner prescribed by the new version of the Consent.

I commit myself to regularly review the text of this Consent and check for the presence/absence of changes to the Consent and the effective dates of such changes.

The recipient of the claim notifies the claimant in writing of the results of its consideration within 5 (five) business days from the date of receipt of the claim.

In case of failure to come to an agreement, the dispute is referred to the court in accordance with the legislation of the Russian Federation.

- 14. The personal information provided by me is stored and processed by the Operator in accordance with the terms of the Privacy Policy posted on the Website.
- 15. I am informed that the Operator takes the necessary legal, organizational and technical measures, or ensures that such measures are taken, to protect personal data from unlawful or accidental access, destruction, modification, blocking, copying, provision, distribution, as well as from other illegal actions in relation to the personal data.
